# Schedule of Membership Dues

(Effective July 1, 2017)

## A. For-Hire Motor Carriers *(Membership dues are based on truck count; maximum of \$4,000)*

**\$500 plus \$20 per truck**

## B. Private Carriers *(Schedule based on miles traveled in Alabama)*

<b>\$300</b> .....	for up to 1 million miles
<b>\$600</b> .....	for 1,000,000 up to 4 million miles
<b>\$900</b> .....	for 4,000,001 up to 7 million miles
<b>\$1,200</b> .....	for 7,000,001 up to 10 million miles
<b>\$1,500</b> .....	for 10,000,001 up to 13 million miles
<b>\$1,800</b> .....	for 13,000,001 miles up to 16 million miles
<b>\$2,100</b> .....	for 16,000,001 up to 19 million miles
<b>\$2,400</b> .....	for 19,000,000 up to 21 million miles
<b>\$2,800</b> .....	for 21,000,000 up to 24 million miles
<b>\$3,100</b> .....	for over 24 million miles
